Article 70-604 Election Summary

"The purpose of 70-604 is to allow HOAs that have excess member income (assessment and fees) in a specific year to refund that excess income to the members

or roll it over to the next year to avoid being taxed on any excess member income. The ruling allows an HOA to make an election that will essentially defer the excess membership income for the year to the subsequent year." -

- This needs to be filed whether we, or our accountants, choose to apply this Revenue Ruling to our tax returns or not. At this time we would not apply for it, but if anything changes in the future, then the application could be made to our yearly tax returns and save the HOA money.
- There is no tax liability to the HOA by filing this form. By filing this form, we are within the tax guidelines for both the Federal Government and the State of Oregon.
